



INVITATION FOR BIDS

1. This Invitation for Tender follows the General Procurement Notice (GPN) for this Project which appeared in *Tender portal Journal* dated 10/07/2018.
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the *Nyasa District Council* during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Design and Build of Fiberglass Engine Fishing Boats**.
3. The *Nyasa District Council* now invites sealed tenders from eligible *and qualified* designer and builder of fiberglass engine boats registered or capable of being registered for carrying out the Design and build of ten (10) fiberglass engine fishing boats.
4. Tendering will be conducted through the *National Competitive Bidding* procedures specified in the Public Procurement Regulations, GN. No. 446 of 2013 and Public Procurement (amended) Regulations, GN. No. 333 of 2016 and is open to all eligible Bidders as defined in the Regulations.
5. Interested eligible Tenderer may obtain further information from and inspect the Tendering Documents at the **Secretary of the Tender Board, Nyasa District Council, P.O. Box 90, Mbamba bay (PMU Office)** from 07:30hrs to 15:30hrs] on Mondays to Fridays inclusive except on public holidays.
6. A complete set of Tendering Document(s) in *English* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of Tshs.100,000.00 (One hundred thousand Tanzania shillings only). Payment should be made through **A/C No.61710002076, NYASA DC OWN SOURCE COLLECTION**. Bidding documents will be collected at Nyasa District Council headquarter (PMU-Office) after submission of Pay In Slip
7. All Tenders must be accompanied by **tender securing Declaration** in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet
8. All tenders in one original plus 3 copies, properly filled in, and enclosed in plain envelopes must be delivered to the Secretary of the Tender Board **Nyasa District Council, P. O. Box 90, Mbamba bay, PMU Office** on or before **09/01/2019 At 12:30HRS**. Tenders will be opened promptly thereafter in public and in the presence of Tenderer's representatives who choose to attend in the opening at the **Nyasa District Council headquarter**.
9. Late tenders, portion of tenders, electronic tenders, tenders not received, tenders not opened at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
10. The Procuring entity is not bound to accept the lowest or any tender.
